Top holdings include cash and cash equivalents, which include commercial paper, U.S. Treasury Bills, money market funds and deposit accounts. Certain terms may be used in third-party publications. “Price to earnings ratio” is a common tool for comparing the prices of different common stocks and is calculated by dividing the current market price of a stock by the earnings per share. “Book value” is the net

asset value of a company, calculated by subtracting total liabilities from total assets. The investment adviser of the Funds defines “free cash flow” as the cash a company would generate annually from operations after all cash outlays necessary to maintain the business in its current condition. “Dividend yield” is the yield a company pays out to its shareholder in the form of dividends. The “Net Worth Sweep” refers to the “third amendment” to the Amended and Restated Senior Preferred Stock Purchase Agreement, which requires Fannie Mae and Freddie Mac to pay all profits to the U.S. Department of the Treasury. “GSE” refers to a “Government Sponsored Enterprise,” such as Fannie Mae and Freddie Mac, which are privately owned, publicly traded companies chartered by the United States Congress.
